REPORTS/PRESENTATIONS

Financial Management Report, January 2009 (Monica Kim, District Treasurer)

In Ms. Kim's absence, Victoria McLaren presented the Financial Management Report (covering 7/1/08 – 11/30/08) and invited the Board to call or email her with any questions. Trustee Resnick asked the following questions; Ms. McLaren offered the following answers:

- When do we receive state monies for last year? No outstanding claims for last year, we are just due this year's claims.
- What is stability of funds in various bank accounts? FDIC coverage has been increased to \$250K, but we also have collateralization coverage.

Committees:

Green Committee (Laurie Osmond)

Fifteen (15) people were in attendance at yesterday's meeting. A wind tower installation company located on Rt. 28 in West Hurley gave an informational presentation. Garden group will meet on Monday for further discussion. Next meeting is 2/2.

Trustee Flayhan moved to have the Audit Committee report placed on this evening's agenda. No second. Instead it was requested that Ms. Flayhan's materials be distributed (which she did) and that the Audit Committee chair deliver the report at the next meeting. All agreed. It was also agreed that the topic of transportation be placed on the next meeting agenda.

DISCUSSION

Board Goals Completion (Dr. Ford/Board President Legnini)

Trustee Resnick suggested the document receive some "wordsmithing." Dr. Ford and Trustees Friedel and Osmond offered to assist.

Strategic Planning Update (Trustees Resnick, McGillicuddy, Legnini)

Per Trustee Resnick, the process is heading into a final plan. The four (4) Task Forces and Core Team met and continued with finalizing the wording. On 1/16, the reports will be finalized and presented. They are looking for 75% approval from the Core Team. If not, there would be rewrites. The final plan will be presented to the BOE during the 2/3 meeting.

Superintendent Mid-Year Evaluation Conference (Dr. Ford)

Trustee Resnick believes the BOE has to work together on this one. Trustee Friedel suggested looking at the form during Executive Session. President Legnini clarified the process. Trustee Wolff thought the year-end version was good, the other one being too wordy. Trustee Friedel suggested bringing both forms to Executive Session. Trustee Flayhan also requested access to the job description and the contract. Dr. Ford explained that such information would be provided during the year-end evaluation, that the mid-year evaluation is less formal.

Pyramid Report – West Hurley Elementary School (Victoria McLaren)

Summary pages indicate the property to be valued at \$650-750K. Although it is good property, it is more valuable including the buildings. Not good for development. Lease value is \$5-10 per square foot: Building 1 - \$56K; Building 2 - \$161K. Yes, calls for leasing have been received (i.e., the kitchen). Leasing it is not appropriate for BOCES—not central enough. President Legnini thought there might be ways to keep the building and have it make money. "\$650,000 does not seem like that much money." Trustee Wolff reiterated that BOCES tries to keep their transportation centralized. Trustee Osmond mentioned previous discussions of having board meeting, administration and still marketed.

Trustee Resnick wanted to know the criterion for who the user might be. What will it mean if there is a population increase and then having to decide between Woodstock and West Hurley schools? Depending on the usage, we may be obligated to perform a lot of work—what would be the costs? Do we want to break even or make a profit?

President Legnini pointed out that the property is zoned residential, not commercial. Ms. McLaren discussed the properties "grandfathered" status. Trustee Wolff said, "Down the road we're going to have to start talking about a capital project." Trustee Friedel does not feel we can do any capital projects at this time, but is hoping federal funds might eventually become available to help.

In Trustee Resnick's opinion, "We as a Board are concerned that the building still costs money, even though it is not in operation." President Legnini wondered if we could find a tenant to offset the costs. Ms. McLaren reminded everyone that in any case, improvement would have to be made first. Trustee Resnick indicated that per foot cost would not pay for the building.

Budget Workshop Preparation (President Ralph Legnini)

President Legnini read report prepared by Victoria McLaren. This year the budget will reflect cuts of \$566K in state aide. District Cuts will need to be made; 2010-11 budget year will be even more challenging. The CPI will dictate budget increase; if CPI is 3.5%, ours would be 3.3%.

Reductions will have to happen in personnel, programs and services. The budget has to be balanced regardless of the fund balance. A special meeting dedicated to the budget is scheduled for this Friday (1/9). Dr. Ford expressed that we have prepared well and need to be very careful and prudent.

Water Tank and Greensand Filtration System Replacement Timeline (Trustee Osmond)
President Legnini reviewed the timeline. Trustee Resnick is requesting a monthly status report.

BUSINESS AND FINANCE

BE IT HEREBY RESOLVED on recommendation by the Superintendent of Schools that the Board of Education of the Onteora Central School District declare the Middle High School **auditorium seats as surplus** and authorize the sale or disposal of these items.

Discussion: Trustee McGillicuddy wanted to know if administration has been in contact with the Green Committee to dispose of the seats. According to Ms. McLaren, board policy dictates that the sale be attempted first. If there is no response to that offer, then we are able to donate the seats via another public notice. Trustee Osmond recommended posting a web notice on "Freecycle". Ms. McLaren explained that whomever is going to take them, has to do so as soon as they are removed, and they must take the whole lot. Trustee Resnick offered to make calls to area non-profits to see if they want them, should the District not be successful in their sale of them.. It is believed there are 400 working seats available.

WHEREAS, in an effort to reduce the cost of electricity, the Ulster County Board of Cooperative Services ("BOCES"), under a Request For Proposal ("RFP") process requested electrical suppliers to submit proposals to sell electricity to BOCES and its member school districts, including the Onteora Central School District ("District"); and

WHEREAS, BOCES awarded the RFP to supply electricity at a reduced rate to BOCES and its member districts to the HESS Corporation ("HESS").

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education ("Board") of the Onteora Central School District approves the **purchase of electricity** from the HESS Corporation; and

BE IT FURTHER RESOLVED, that the Superintendent of Schools is authorized to **execute the Base Agreement** for the Purchase and Sale of Electricity and Transaction Confirmation with the HESS Corporation subject to the District's legal counsel's final review and recommendation of acceptable terms and conditions.

Discussion: According to Ms. McLaren, it is a variable rate, currently below our rate.

OLD BUSINESS

Trustee Friedel inquired about the status of the locker situation. Dr. Ford explained that there has been no action due to our spending slowdown. President Legnini mentioned Trustee Flayhan's previous request to use the funds for student needs, such as the MS/HS science labs. Trustee McGillicuddy does not think we can spend any more money. Trustee Osmond suggested going to the teachers and asking them for their input regarding the science labs. President Legnini indicated that if the fund balance of \$350K were put toward the tax levy, it would reduce the levy. Trustee Resnick said that all expenditures needed to be looked at and prioritized. Trustee Flayhan suggested asking the teachers what is needed for an excellent lab. Trustee Wolff asked if the money allotted for the lockers was voter-approved funds. No. Trustee Resnick liked the idea of asking the teachers for input, while Trustee Osmond cautioned not to promise anything when doing so. A vote was taken on asking teachers for input. A majority agreed.

Trustee Resnick asked what the Board would need to do in order to be kept abreast of the Auditorium renovation project. She will distribute outline received from NYSSBA.

Trustee McGillicuddy asked if Ms. McLaren had prepared a retirement package? And if so, could she bring it to Friday's meeting. Ms. McLaren explained that there are not many retirements this year.

Trustee McGillicuddy asked how the parents of students who lost items from the boys MS gym lockers were communicated with. Dr. Ford indicated that she understood that the Athletic Director and the Principals spoke with those parents.

Trustee Friedel asked for the following:

- 1) Free & Reduced Lunch application figures for the past 3-5 years.
- 2) In spite of schedule changes, can all the Late Busses still run? Dr. Ford indicated that Mr. DiGiovanni informed her that modifications were made to accommodate these schedule changes.
- 3) Can a Late Bus schedule be posted on the website to allow for better communications so children are not left unsupervised?

Trustee Resnick announced that www.Cancellations.com will send an email to anyone who registers announcing school delays/closings. Trustee Friedel commented that the artwork posted by our Webmaster Cheryl Formont is absolutely beautiful. Trustee Flayhan stated that the Steering Committee info on the OCSD webpage could now be removed. Trustee McGillicuddy indicated that the Transportation section of the website is out of date Dr. Ford said she will meet with Ms. Formont to go over all the changes. Consensus reached.

PUBLIC COMMENT

Sante E. Moesle

Does not believe that CPI of 3% is correct, believes it is 6-6.5% inflation. NYC schools might want to develop pilot programs at West Hurley. Four months ago the West Hurley School property was worth \$12 million (this dollar amount was confirmed by Sante—if had the opportunity to correct what he said, he would have it read one and one-half years ago—however, Sante knows such corrections cannot be made to minutes, as they have to reflect what was actually said, not what may have been intended). If the building were leased, it would be good if it were used for learning. WIC now provides organic food.
