Trustee O'Connor reported that Assemblyman Cahill's office contacted her with information about the 28% reduction in transportation aid from last year. One interesting reason is that there is an increase in our land value and an increase in our wealth. The data showed that second-home owners are registering their homes as their primary residence here. He is making it a priority to get the formula changed.
