- 5 seminars with the basic theme being rural schools
- Small district upstate attracts foreign students
 - Law is foreign students can only get a 1 year visa
 - Town is building a dorm
 - Entire district is 55 students
 - International Student Industry group is related to this program
- Center for Rural Schools at Cornell has money they must utilize
 - Suggested they look at their online tools to look at trends going on in districts
 - Allows one to do "what if" scenarios
 - Give school districts a way to look at schools in district from a community prospective, instead of just educational
 - use money as community not just as district
- A member of the Board of Regents discussed consolidation:
 - Districts with a population of under 1500 students can be successful, but
 Onteora is too large in area
 - Legislature has not pushed consolidation
- Head of Rural Schools Association discussed sharing services very generally

- 15 Board of Regents seats
 - 10 seats from Westchester and below
 - 5 from boroughs of NYC
 - Upstate is not well represented
- Declining enrollment average is 13% a year, but the Onteora communities are not succeeding in bringing people back to the community once they leave

Resolution: WHEREAS, the Onteora Central School District ("District") Board of Education ("Board") is proposing to replace the existing Fire Alarm System at the Middle/High School and the Bus Garage ("Project"); and WHEREAS, the Project shall be constructed in accordance with the New York State Petroleum Bulk Storage Regulations: and WHEREAS, the proposed Project is a routine activity of the District and/or the replacement, rehabilitation or reconstruction of an existing facility that qualifies as a Type II action set forth in 6 NYCRR Part 617.5, State Environmental Quality Review Act ("SEQRA"): WHEREAS, the proposed Project includes no other potential involved agencies that have been identified in regards to the Project; and WHEREAS, the Board has considered the information and documentation, which describes the design and intent of the proposed Project; NOW, THEREFORE, BE IT RESOLVED, that the Onteora Central School District Board of Education, based upon the record before it, including the general, specific and detailed knowledge of the Board of the proposed Project and under the applicable standards of SEQRA and 6 NYCRR Part 617.5, hereby determines that: a. The proposed Project is classified as a Type II Action; and b. In accordance with Article 8 of the New York State Environmental Conservation Law, the Board is not obligated to conduct any further environmental review of the Project. NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE ONTEORA CENTRAL SCHOOL DISTRICT AS FOLLOWS: 1. Pursuant to State Environmental Quality Review Act (SEQRA) amended June 26, 2000 and effective July 12, 2000, and the resulting Commissioner of Education Regulation 8 NYCRR amended effective November 15, 2000, the Onteora Central School District will act as Lead Agency, for the Fire Alarm Reconstruction Project at the Middle/High School and the Bus Garage, in determining compliance with SEQRA. 2. NYSDEC Regulations Part 617 define Lead Agency as follows: "Lead agency means an involved agency principally responsible for undertaking,

funding or approving an action, and therefore responsible for determining whether an environmental impact statement is required in connection with the action, and for the preparation and filing of the statement if one is required." 3. A copy of this resolution shall be placed on file in the office of the District Clerk where the same shall be available for public inspection during business hours. This resolution shall take effect immediately.

- This is a health and safety issue so it is an ordinary contingent expense. Money will be taken out of the fund balance.
- Will go out to bid estimate is \$400,000
- Replacing system not repairing system so can not come out of repair reserve
- This resolution allows the State to review the plans and specifications put together by the architect
- System is failing in certain areas

Trustee Spencer stated that the resolution states "Based on Board review of project" and Board has not reviewed project but this resolution just allows the State to review the project as a Type II project that does not need to go through the SEQRA process

Trustee Kurnit stated that the architect will be at the next Facilities Committee meeting to discuss this project
