<u>Valerie Petroski Story</u> – Support Dr. McGill's decision to put an armed officer in Woodstock School. Need to be proactive – presence of an SRO is proven deterrent <u>Marcus Ferrara</u> – Threat at Woodstock frightened his child and she is not in school

8. Discussion

8.01 Practices and Policies on Testing (proposed 6:30 duration 1 hour) 6:45

- Information on Board Docs initial discussion.
- Many concerns on amount of testing in the schools Commissioner John King's forums were difficult
- Pearson writes tests that the District must purchase
- Race to the Top Funding most schools did not get much
 - o Spending more than receiving
 - Districts are withdrawing

- Use data in a clinical way to tell us how are they learning, what are they learning and what can we do to improve learning
- If we don't participate in the State Assessments with 95% participation for 2 years in a row, will be labeled a School in Need of Improvement
 - o 6th grade may not have made 95%, will know in the spring
- Sienna Poll 52% too much testing
- Commissioner King says that on early grades, should back off on testing
- Student perspective: Students and teachers do not know what kind of test for which they are preparing, teachers do not have a clear picture
 - Consider more than the money aspect
 - Making students numbers forgetting about creativity and innovative classroom techniques
 - Stressful in general
- Falsehood that if we turn away money do not have to follow mandates
 - o Even without the money all testing, APPR, etc. is mandated
- Assessment of students is about:
 - Align instruction
 - Identify students weaknesses
- Utilizing Response to Intervention
- Stop putting pressure on students to do well on students
- Manage testing in this District to reduce stress
 - Lack of cohesive behavior in the District, not have different procedures for different classes
- Great fears about New York State releasing data that could be accessible by public
- Working on instructional practice, that is how we did so well compared to other Districts

Assistant Superintendent for Curriculum & Instruction Marki Clair O'Rourke

- Regents Reform Agenda has 3 pillars: Common Core state assessments;
 School Based Inquiry data driven instruction; APPR for teachers and principals
 - Each has assessments
 - Teams of teachers get together to review student data and make plans for appropriate action
 - o Team of 7th and 8th grade teachers doing a Pilot program from the State
 - 20 minute mini tests in place of weekly guiz to get more data
 - Will really tell the District if we should adopt the Standards
 - Pilot program is not by the State
 - Working on using the NWEA assessments in K-3 to set rigorous, fair goals for students
 - Data Driven Instruction at Middle School
 - Took data from assessment, developed an action plan
 - What standards did all students have difficulty
 - What standards did some have difficulty
 - Look at assessments -are students have difficulty on any one assessment item
 - Data team did study group on using data to inform instruction

- Common midterm and final and AP assessments all students taking the same test - not all taking the same classes, why are they all taking the same test?
 - Need to look at students as individuals
 - o Is there differentiated in assessment as well as teaching?
- Elementary Schools data teams meet every summer, but not happening in same way
- Assessment at elementary using NWEA data, Response to Intervention more ownership of teachers to help students get over problems
- Student Learning Objectives tells you if you do not have a State assessment in that grade, how do you measure student growth
- Offering diverse HS classes to help students prepare for college, but assessments are all on same level
- What are we doing so that at the end of the Common Core pipeline we have a sound educational program?
 - We do not have an aligned local curriculum across all schools for Math ELA. Science
 - Have on Elem level have a brand new math program
 - Reading have Readers/Writers Program
- Have a time study of time in classroom with teachers, vs. testing and other activities done
- Middle School is using the Common Core Curriculum themselves
 - Using the modules and asking the teachers to take the best of what they can find in them for their students
 - No proof that these resources will make students more career and college ready
- 8.02 Independent Contractor Contracts to Board for Review (proposed 7:30 duration 30 min)

Trustee Spencer explained that the Corrective Action Plan by the External Auditor has been discussed by the Audit Committee

- Recommended that the Independent Contractors were being moved on too quickly and were approved after POs were approved

- Contracts cover mentors, grounds, etc. for a great deal of money, which Superintendent has sole responsibility, Board should share
