NOW, THEREFORE, BE IT RESOLVED, that the Board of Education submit the following proposition to be included on the ballot at the Annual Meeting and Election, to be held on May 16, 2006:

Shall the Board of Education of the Onteora Central School District be authorized to establish a capital reserve fund, pursuant to Section 3651 of the Education Law, for the following objects and purposes: construction of additions and alterations to, and reconstruction and renovation of, District wide facilities, and/or rehabilitation and reconstruction of any of the District's facilities that are identified in the District's building condition survey, in the

ultimate amount not to exceed \$3,000,000; and that the sum of \$3,000,000, or so much thereof as may be necessary, shall be raised from the unexpended and unencumbered funds levied upon and collected from the taxable parcels of property situate, lying and being in the District over a probable term not to exceed five years?

AND BE IT FURTHER RESOLVED, that the District Clerk be authorized to publish notice of said proposition in the manner required by Section 2004 of the Education Law.
