- Title Grant Monitoring Visit In the absence of Assistant Superintendent Deborah Fox, Superintendent Ford reported that the auditors from the State came to look at how our percentage of Highly Qualified teachers is improving and how money is spent on staff development. We did very well. In five years we have moved from 71% to close to 100% of Highly Qualified teachers. They were very impressed with our CDEP Plan and will be using the format of our

plan as a model for other districts. The audit wound up in a record 2 1/2 hours. Kudos to Deborah Fox and Victoria McLaren and everyone who serve on the committee specially Brigid Shultis who put together a huge binder of necessary information. They will have a report for us in about 30-60 days. Principal Job Description – Superintendent Leslie Ford reported that since Gayle Kavanagh is retiring as our Middle School principal, we are now screening applicants and as part of the hiring process have updated the job description to identify behaviors we will expect an administrator to be able to do.
