EMPLOYMENT CONTRACT Amanda Allison Assistant Superintendent for Pupil Personnel Services Onteora Central School District July 1, 2023 – June 30, 2028

1. ARTICLE ONE - LEAVES

- a. <u>Sick Leave</u> The Assistant Superintendent for Pupil Personnel Services shall be granted eighteen (18) paid days per year for personal and/or family illness in the immediate family with a maximum accumulation of 220 days. Accumulated sick leave may only be used for personal illness.
 - i. Upon commencement of employment, the Assistant Superintendent shall be credited with twenty-four (24) sick leave days in a bank solely for personal use. As sick leave days are accumulated, this credited allotment shall be decreased by the corresponding number of accumulated days until the credited allotment is depleted.
- b. <u>Bereavement</u> Death in the immediate family five (5) days paid leave per occurrence. A maximum of three (3) days paid leave for a death in the non-immediate family.
- c. <u>Personal Leave</u> Four (4) days paid leave per year, unused days transferred to sick leave.
- d. <u>Jury Duty or Court Leave</u> no charge.

2. ARTICLE TWO - WORKING YEAR

- a. 12-month employee July 1 to June 30 in school years
 - b. <u>Vacation</u> Twenty-one (21) days of paid vacation annually, which may carry over ten (10) days from one year to the next. The year in which tenure is received and thereafter will be entitled to twenty-six (26) days of paid vacation annually. The district may buy back up to ten (10) unused vacation days annually at 1/240th of the annual salary per day, subject to scheduling, as approved by the Superintendent.
- c. <u>Holidays</u> All holidays listed in the school calendar, which include the following: Fourth of July, Labor Day, Rosh Hashanah (provided school is closed), Yom Kippur (provided school is closed), Columbus Day, Veteran's Day, Thanksgiving Day and the day following, Christmas (2 days), New Year's Day, Martin Luther King, Jr. Birthday, President's Day, Good Friday, Memorial Day, and Juneteenth. The Assistant Superintendent is expected to work during school recess periods unless she elects to utilize vacation time.

d. <u>Snow Days</u> - Employees will not be expected to report to work when school is closed due to inclement weather. This implies adherence to project and report deadlines. If school is closed for a reason other than inclement weather, employees will be expected to report to work at the Superintendent's discretion.

3. ARTICLE THREE - NEGOTIATIONS PROCEDURE

- a. <u>Length of Agreement</u> This agreement is for the school year 2023-2024, 2024-2025, 2025-2026, 2026-2027 and 2027-2028.
- b. <u>Termination of Agreement</u> The agreement may be terminated upon a minimum of sixty (60) days of written notice.
- Successor Agreement Timeline The Superintendent shall commence discussions and analysis for a successor agreement no later than April 1, 2028.

4. ARTICLE FOUR - INSURANCE BENEFITS

a. <u>Health Insurance</u> - The District will pay 85% of individual or family premium for health insurance of the District-offered DEHIC plan. If the Assistant Superintendent chooses to waive coverage, she must demonstrate that she has adequate alternative coverage. The Assistant Superintendent shall be entitled to an annual payment in lieu of health insurance prorated for the length of employment in the work year as follows:

a. Family: \$3,000b. Individual: \$2,000

- b. Health Insurance Upon Retirement Upon retirement from the District in accordance with requirements of the New York State Teachers' Retirement System ("TRS"), with at least eight (8) years of service with the District, the Assistant Superintendent shall be eligible for health insurance in retirement. If the Assistant Superintendent elects individual coverage, the District's contribution for health insurance premium payments shall be at the same percentage of the District contribution in effect for the retiring employee as of the date of retirement. If the Assistant Superintendent elects family coverage, the District contribution for health insurance premium payments shall be 50% of the difference between the individual and family premium, plus its retiree contribution for individual coverage.
- c. Other The District will pay \$400 annually for documented expenses or premiums for self or immediate family for disability coverage.

<u>Payroll Savings</u> - The District will make available Tax Sheltered Annuities through payroll deduction. Payments for these annuities shall constitute a reduction in salaries as authorized by the administrator and will be deducted automatically by the district from each paycheck. The District will select one company to serve as a forwarding agent.

- d. <u>Flexible Benefit Plan (IRS Section 125 Plan)</u> The District shall make available a flexible benefit plan for medical premiums; un-reimbursed medical expenses, and dependent care expenses.
- e. <u>Welfare Plan</u> As an Onteora administrator, the Assistant Superintendent shall be eligible for membership in the OTA Benefit Trust. The District will fund the benefit trust and make payments for the total amount.

6. ARTICLE SIX - EVALUATION AND TERMINATION

- a. <u>Evaluation</u> The Superintendent will perform an annual evaluation prior to the renewal of the agreement.
- b. <u>Terms of Employment</u> The Assistant Superintendent for Pupil Personnel Services is a tenured employee.
- c. <u>Termination</u> Any termination of employment during such probationary period will be in accordance with Education Law §3020(a).
- d. The position of Assistant Superintendent for Pupil Personnel Services shall not be abolished during the term of this agreement, provided however that in the event that the Board of Education shall determine to abolish the position of Assistant Superintendent for Pupil Personnel Services the Board of Education shall pay to the Assistant Superintendent for Pupil Personnel Services as compensation a lump sum payment equivalent to her then annual compensation at the conclusion of her services as Assistant Superintendent for Pupil Personnel Services in addition to her compensation during the period of her service.

7. ARTICLE SEVEN - PAYMENT OF PROFESSIONAL DUES, CONFERENCES, AND TRAVEL REIMBURSEMENT, CELL PHONE AND LAPTOP COMPUTER

- a. <u>Professional Membership Dues</u> The District will bear the cost of annual dues on behalf of the Assistant Superintendent for Pupil Personnel Services for membership in up to three (3) professional organizations, as approved by the Superintendent.
- b. <u>Conference and Travel Reimbursement</u> When attending any school- related conference or function outside of the District, the District will reimburse the Assistant Superintendent for use of her personal automobile at the mileage rate set by the District for all employees. Reasonable meals, lodging, conference registration fees, and charges to the administrator's cellular phone relating to district business willbe reimbursed.
- b. <u>Cell Phone and Laptop Computer</u> The District shall provide the Assistant Superintendent with a cell phone and a laptop computer for use for official District Business and incidental personal use. Such items shall be the

property of the District and shall be returned to the District at the time the Assistant Superintendent leaves the active employment of the District. Alternatively, if the Assistant Superintendent chooses to use her personal cell phone for official District business, the District shall contribute \$50.00 per month towards the cost of her monthly cell phone bill.

8. ARTICLE EIGHT - COMPENSATION

- a. <u>Annual Salary</u> The annual salary of the Assistant Superintendent for Pupil Personnel Services for the 2023-2024 school year shall be \$155,500.00. The base salary shall be increased by 2% + \$2,500 for each subsequent year.
- b. <u>Salary Increases</u> The Superintendent shall base subsequent year salary increases upon performance and evaluation. Salary increases for the school year will be added to the prior year's base salary to be agreed upon by the Superintendent and Assistant Superintendent for Pupil Personnel Services and shall be subject to approval by the Board of Education.
- c. Reduction in Salary The annual salary shall not be decreased below the amount paid in the preceding 12-month period.
- d. Assistant Superintendents with a doctoral degree shall be paid a stipend of \$2,000 per year.
- e. Longevity for administrative service with the Onteora Central School District shall be paid as follows:

5 years \$1,000 7 years \$1,500

10 years \$2,000

Longevity shall not be cumulative.
