6. Superintendent District News

6.01 Report on the Woodstock Safety Audit (proposed 7:20 duration 30 min) 7:20

Superintendent Phyllis McGill thanked the parents, faculty, staff and community members that she has met with in the last few weeks

- Most important is that the students are secure
- Goal is to improve: Safety Audit in Woodstock School, will share results with the Board
 - Brenda McGuire consultant in the area of safety
 - working closely with State and Woodstock police
- In visits to the Woodstock school has observed a warm, welcoming environment
- Teachers remarked at the positive atmosphere

Brenda McGuire

- Former educator
- Former trainer for drug abuse and violence prevention for the schools
 - State of Michigan and Washington DC did safety audits
 - Washington DC K-8 buildings helping to create safety programs
- Parents and teachers should look at Code of Conduct
 - Don't just hand out, but go through the behaviors
- Concerns:
 - Position secretary in office to be at the window
 - Do not allow people passed 2nd doors
 - Badges need to be numbered and signed out and in
 - o Better instructions at buzzer for door
 - Look for IDs if you don't know the people
 - Stop people who do not have a badge in the building make notice of people in the building
 - Let students in when buses arrive, instead of students staying on the bus
 - At dismissal, parents should stay in car and each have a card in car that matches the child's tag, child comes out
 - o Crisis team will be trained this week, but they are very competent
 - Parent to join team
 - Parents more educated as to processes in school for visiting and early pick up
 - School needs to be consistent with all parents

- Hire a SRO
- Open area next to a driveway needs a gate
- Fence-in section of the playground that is not fenced
- 5 or 6 classes + Spec Ed class is too many children with too few adults on the playground
- Kindergarten lunch time not enough adults
- Parking area in front should be a one way road
 - Teachers should all park in the back
- Better manage traffic when buses are in front with lights on and doors open
- Exit windows in school are blocked in some classrooms
- Put number of each classroom in window to see from outside
- Staff should wear badges at all times

Discussion:

- Process at the Board meeting is that the Board hears the presentation, then has discussion with the Board and presenter, then public be heard after discussion
 - Public can ask question or make a comment
- Most of the things are not major, not trying to change culture and climate
 - Most elementary schools need to be compliant
 - All elementary schools should be following this
- Take safety and security very seriously and take the responsibility
 - Security vs. liberty schools are meant to be nurturing places
 - o Parents are used to being able to walk to their children's classroom
- Safe Schools, Safe Students conference booklet is on Board Docs
- Superintendent made decision to put policeman on premises at Woodstock
 - Having armed policeman at a school for 5-9 year olds is disconcerting
- Address as a mental health issue as well through social workers and psychologists
 - Dealing with a student with anger issues
 - Woodstock teachers have a connection with their students
 - Keeping their eyes and ears open can help
- How to bring law enforcement in as part of the team
 - Ongoing safety audits
- Develop early warning system prevention program
 - Mentor programs peer or adult to children
 - ISS set up to teach skills so children do not come back there
 - Purchase a program
- SRO most important is the relationship that the officers have with the students and families which allows them to be prevention

- Tests: Bad Assessments Good
 - Presented by 2 teachers and an Asst. Superintendent for Curriculum & Instruction
 - Importance of assessing students in a timely manner during the school day
 - Variety of assessments done in simple, various ways
 - o Took a 7th grade reading test to see the different results in the room
 - Board can and should expect periodic reports on assessments in reading and math
- Board Officer Round Table
 - Chose topics on common challenges for School Boards and came up with solutions
 - Will be shared on NYSSBA web site
- Governance Seminar: Are you a Visionary or Micro-manager?
 - Consultant from NYS Caucus of Black School Board members
 - The vision the Board creates is really what tells students, teachers, and parents where the District is going
 - Can be a good agent of change

 - o All school participating, data to State
 - Have asked about bankruptcy no answers
 - 60% of funding comes from property tax difficult with tax levy limit
- Beyond Compliance
 - Collaboration for APPR class Superintendent and NYSUT Labor Relations Spec. facilitated together
 - Worked out an innovative plan that minimized risk and left a positive educational climate
- BYOD Bring your own Digital Device
 - Complicated discussion
 - Generalized forum for information
- Strategic Taxpayer Relief through Innovative Visions in Education
 - Mike Hein, Ulster County Executive facilitated
 - Moved programs into a closed elementary school in Kingston
 - STRIVE program help municipalities utilized closed buildings
- Collaboration that works
 - Early HS program
 - In Ballston Spa started with 11th grades, then went back through the grades
 - Taking advantage of P-Tech grants
 - In an area with big business
 - Get students graduating from HS with 2 years of college credit

 - Serial threats of gun violence resolution falsely issuing gun threats

is not illegal, bomb threat is illegal

- NYSSBA resolution to make it illegal to falsely threaten gun violence, passed
- Support P-16 systemic approach (Pre-K through college) alignment with colleges – passed
- Most spirited discussion was over safety
 - Called for funding for efforts to enhance school safety
 - Debate because it calls for an SRO
 - Experienced Board delegates in attendance informed that any money given for safety will be taken away from education
- Leadership Academy
 - Board relations
 - Relevant to the upcoming Board retreat
 - Presenter will be facilitating retreat
 - Common core: Commissioner spoke
 - Opposition from school boards for the speed at which to engage Common Core Standards
 - Saving the Great American School Board
 - David Little spoke
 - FOIL following all procedures at Onteora
 - Bill Daggett Digital Literacy Career and College Ready
 - College on Track
 - By 9th grade have some sort of digital device
 - One app that gathers a dozen applications
 - If students are still handing in homework on paper, they will be surprised by the electronic submissions at college
 - Watch lessons at home come in to do write up
 - 21st Century Engagement in Action: Focus on Teachers and Leadership Development
 - PDF on Board Docs "NELMS" Greece School District
 - Due to the APPR, Common Core and RTI administrators and teachers need a support system
 - Got a grant to take teachers and make them teacher leaders
 - APPR approach focused on the 80% that they can control
 - Teachers in need of improvement is the District's failure
 - Implementation of Common Core Standards assessment and curriculum
 - Can't control assessments so focused on the standards and curriculum
 - Create new paradigm
 - Used NYC Leadership Academy
 - Regular coffee mornings with Superintendent
 - Principals travel to help other schools
 - Study how they did it and see how we can implement
- Company that tracks students after they graduate
 - Can help determine if they were they prepared for school
- National School Board Association-want people from every state attending

Superintendent Phyllis McGill:

Trustee Fletcher:

- Current Superintendent contract utilizes the school year, but evaluation is December
- Evaluation should be done:
 - As a progress report from the Superintendent in Nov/Dec
 - Then an interim evaluation in Feb
 - Superintendent gives a 2nd progress in April
 - All tied into Board goals with Superintendent action items
 - Then the Board does the Superintendent evaluation
 - Self-evaluation should be provided by the Superintendent to the Board in Executive Session and have a chance to respond
 - Not an extended conversation
- Look at Texas and Oregon as good evaluation models
- Of the 4 evaluation approaches most used
 - #1 performance appraisal
 - #2 objective analysis
 - #3 Check list rating system
 - #4 Essay

Limit goals to 5-7 short goals

- Superintendent goals should be public
- Only the Superintendent Final composite score is FOILable

Discussion

- Change contract in the future to reflect evaluation practice
- Trustee McGillicuddy and Superintendent Phyllis McGill will look at evaluations
- Take up a couple of procedures recommended for evaluation in December
- Align closer to school year in future

 - o no difference from his perspective
 - No definitive answer
 - Will call Spackenkill and Hyde Park
 - Will receive \$21,000 this year from RTTT
 - Spending more than receiving

- Promote coding in schools at all ages
- Programs to use with students to teach about that kind of learning
- When opportunities avail themselves we need to take advantage of it
 - Students don't get to coding and development of software
- Audit of courses for database design, web site, coding, etc. and how well we train our students
- Part of larger discussion on STEM curriculum need aligned math curriculum that takes into account engineering and math.
 - o Do we have an aligned curriculum, if not, what is the plan?
- Logical exercise that is where their future lies
- Few states have coding connecting to STEM and math districts have to focus on other things, so it is not of paramount importance
- One hour of coding is the event during that week see if it is possible
